Notice of All Applicants - California Department Fish and Game County of Kern CEQA documentation Fees

Pursuant to California Fish & Game Code 711.4, the City of Delano is required to collect the following filing fees for the Kern County Clerk, on behalf of the California Department of Fish & Game, for the following projects:

1. A \$50.00 County Documentation handling fee is collected for any project that requires the filing of a Notice of Exemption prepared pursuant to the California Environmental Quality Act.
2. Any project for which a Negative Declaration or Mitigated Negative Declaration is prepared pursuant to the California Environmental Quality Act: \$2,210.00 [Fish & Game Code 711.4(d)(2)] plus a \$50.00 County documentation handling fee.
3. Any project for which an Environmental Impact Report is prepared pursuant to the California Environmental Quality Act: \$3,069.75 [Fish & Game Code 711.4(d) (3)] plus a \$50.00 County documentation handling fee.

Please note that these fees may be adjusted from time to time by the California Department of Fish and Game.
